Win-Win Approach For Construction Project Delivery By Awarding A Design-And-Build Contract (1st Run)



Introduction

In the 1950's and 1960's, most construction projects in Singapore were implemented by project owners first hiring technical consultants to prepare a design for their projects and then awarding a contractor to construct it based on design. Such procedure appeared to be workable and satisfactory to all players of the construction industry. However, in the mid 60's and early 70's when design and construction of high-rise building, large multi-usage complexes and mega-infrastructures began to be undertaken, coordination of design and construction works became more and more vital and Because of the lack of experience and important. diligence, design and construction works were not properly and timely coordinated, resulting in improper dovetailing of and undue delay to overall project delivery. It was identified then that such pitfalls were basically caused by splitting the responsibilities of design and construction. Led by government agencies, the construction and development industry came forward with the design and construction responsibilities on one shoulder, the shoulder of a design-and-build contractor. Hence project owners began to award design-and build contracts (D&BC). It was unfortunate that at that time, project owners as well as contractors had not quite equipped themselves with appropriate knowhow in respect of the documentation, modus operandi and the ins and outs of a D&BC. Furthermore, many of them also failed to understand and appreciate the real and principal objective intended to be served by awarding such form of contract. Hence, many so-called D&BCs awarded in Singapore were and still are in hybrid forms.
