A postgraduate master's degree or doctoral degree in Mechanical or Electrical Engineering or Building Engineering from any university recognised by the Professional Engineers Board for registration as a professional engineer under the Professional Engineers Act (Cap. 253); **Minimum two years of such relevant practical experience in full-time supervision of building works in building sites in Singapore.**
- 3. A Chartered Engineer registered by the Engineering Council United Kingdom in the Mechanical or Electrical Engineering or Building Engineering; **Minimum two years of such relevant practical experience in full-time supervision of building works in building sites in Singapore.**
- 4. A university degree in Mechanical or Electrical Engineering; subjected to approval by the Joint Accreditation Committee. Minimum two years of such relevant practical experience in full-time supervision of building works in building sites in Singapore.
