1. A local diploma from any local polytechnic in Mechanical or Electrical Engineering or Building Services; Minimum two years of such relevant practical experience in full-time supervision of building works in building sites in Singapore.

2. A foreign Diploma in Mechanical or Electrical Engineering or Building Services. Minimum three years of such relevant practical experience in full-time supervision of building works in building sites in Singapore, Malaysia or Hong Kong is required. Interview required.

3. A higher certificate or GCE 'O' Level in technical stream. At least 10 years of practical experience in full-time supervision of building works in building site is required with minimum of 4 years of such relevant practical experience in Singapore. Interview required.

4. A foreign degree in Mechanical or Electrical Engineering or Building Services; Minimum two years of such relevant practical experience in full-time supervision of building works in building sites in Singapore. Interview required.

Professional Interview is a mandatory requirement.
