3. A higher certificate or GCE 'O' Level in technical stream. **At least 10 years of practical experience in full-time supervision of building works in building site is required with minimum of 4 years of such relevant practical experience in Singapore. Interview required.**
  
4. A foreign degree in Mechanical or Electrical Engineering or Building Services; **Minimum two years of such relevant practical experience in full-time supervision of building works in building sites in Singapore. Interview required.**
