Please register with IES/GeoSS accordingly after successfully passing the Test for the registry of QPP and CB (Technical Expert) and Piling Auditor whenever applicable.

Certification Bodies are to be accredited by SAC Accreditation Panel accordingly under CT31 for an Accreditation Scheme for Certification Bodies.
